President's Report

Hello again

The weather is hotting up and the clouds are starting to build up, so that must mean the shows and trials are becoming less frequent. Although the exhibitions are slowing down, unfortunately neither Council nor the Office enjoy this luxury.

Due to the amount of titles, litter and semen registrations and import registrations that were received during the June, July, August period, there was a backlog. Darien has worked tirelessly to get these done as soon as possible and she needs to be commended for her efforts.

I ask members to understand that we only have one person working part time doing all of our processing and customer service and this takes time. Everyone can help the process along by ensuring all of the paperwork for your application is fully completed and correct. Having to chase up missing paperwork or find errors not only slows your application, but also all of the other applications being done.

Councils workload also doesn't slow down this time of year, the first Australian National Kennel Councils Limited Board meeting is taking place in Brisbane on 15 & 16 October and Council has had to go through not only the agenda, but 43 attachments (over 30mb) of information in order to formulate our position on all of these issues.

I was hoping to include the agenda items in this issue, but due to its physical size and the short period between its receipt and publishing this has not been possible.

Here is a brief run down on the main points:

Put forward by DOGS NT:

A national set of Conformation Show rules- if adopted members Australia wide will be given the opportunity to contribute towards these National rules.

Change to ANKC Ltd regulations part 5 Shows THAT ANKC Ltd Regulations Part 5 Show, SECTION 1; 1.1 Classes for Exhibit at a Show, be amended to include the statement:

No Classes, for which points may be earned towards an ANKC Ltd approved title shall be offered at a show unless those points are to be awarded to all exhibits eligible to receive them under these regulations.

Put forward by other member bodies:

Several relating to White Swiss Shepherds:

Integration of locally bred non ANKC Ltd and ANKC Ltd White (German) Shepherd Dogs into the ANKC Ltd White Swiss Shepherd Dog breed pool.

Relax Re-registration requirements for Imported White Swiss Shepherd Dogs

Litter Registration Limitations for White Swiss Shepherd Dogs - Hip and Elbow Scoring

Notations on Pedigrees – Hip & Elbow Scores of White Swiss Shepherd Dogs

Re-registration requirements – White Swiss Shepherd Dog

Amendments to Code of Practice to include social media sites

Baby Puppy in Group/Baby Puppy in Show be included as an optional class for shows being run using Group 1 – 4 placements system

President's Report

Grand Champion to revert back to pre 2010 regulations – 1000 points only
Introduction of New Conformation Title – 'Supreme Champion'– 1000 points PLUS 3 BIS or 10 BIG/BISS
Change to Age Limit – Junior Class to be 9 months and under 24 months.
Standardisation of all ANKC Ltd certificates.

If anyone member would like further information or wishes to express an opinion on any of these issues please contact me as soon as possible.

I don't like to finish on a sad note, but the Territory is losing one of its stalwarts, Carmen Sinclair is moving to Queensland. A former NACA President, trials judge and exhibitor in both Conformation and performance disciplines and an all round great lady, I for one will miss her knowledge and expertise.

Withdrawal of Border Collie Litter Registration Limitations (LRL)

We refer to the Border Collie Litter Registration Limitation (LRL) resulting from the 2009 Breed Survey.

At the request of the National Border Collie Council the LRL's as surveyed in 2009 will be withdrawn until they have been reconsidered by the National Border Collie Breed Council.



Until that has occurred and the ANKC has received further advice from the National Border Collie Breed Council there are no limitations on registration of Border Collie litters.

Clause 8.7 has been removed from ANKC Regulations Part 6 at this time and the ANKC website will be updated accordingly.
